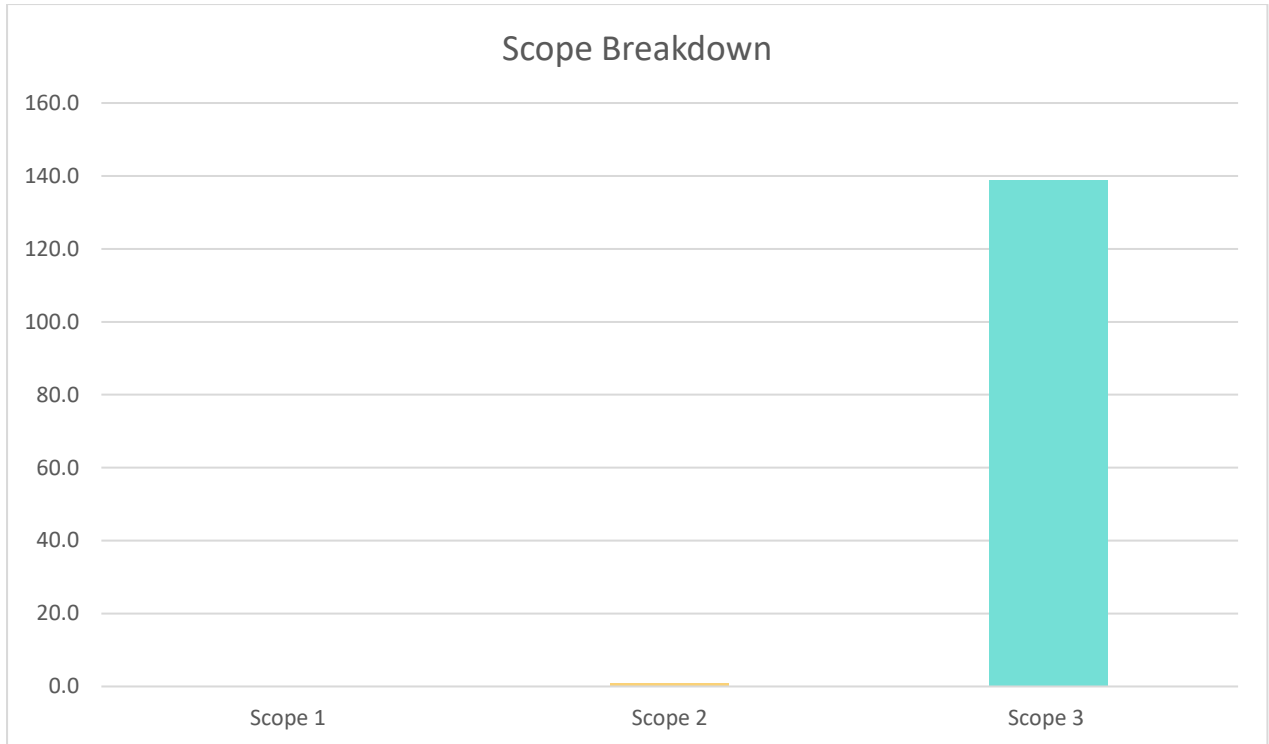
Commitment to achieving Net Zero

Emissions reduction targets

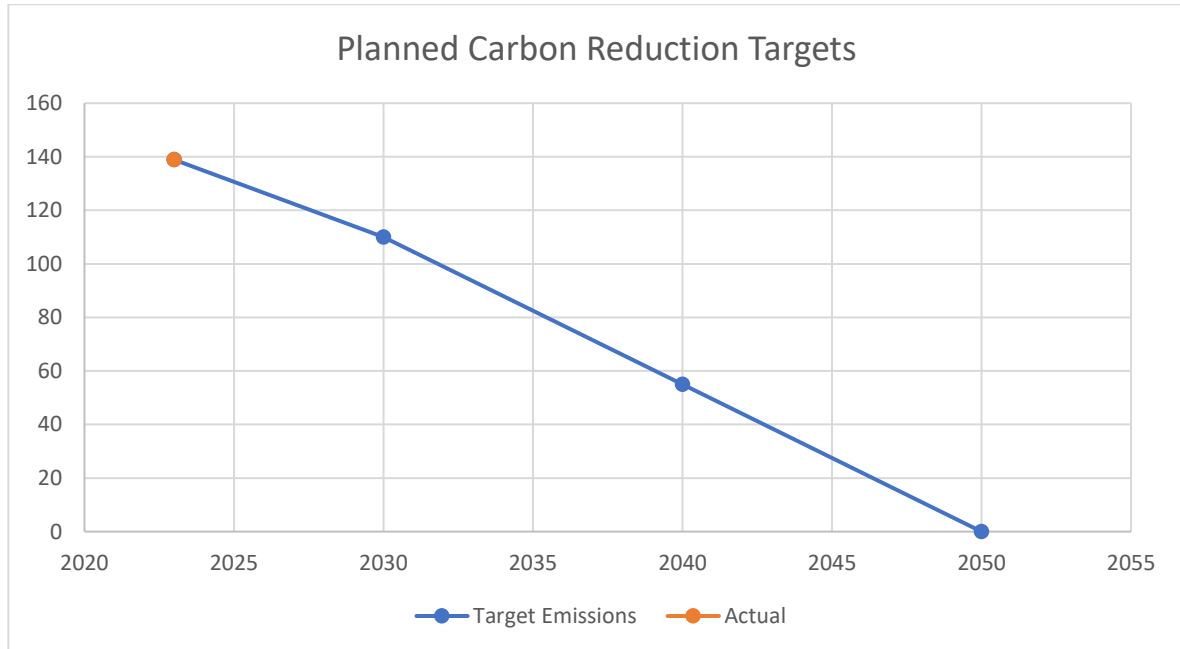
Develop consulting has not previously published a Carbon Reduction Plan. Whilst we are not a high carbon organisation, we recognise that more can still be done to achieve our target of being a net zero organisation by 2050.

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to 110.0 tCO₂e by 2030. This is a reduction of 20.8%

We believe this will be achieved primary by the shift from fossil fuel-based vehicles being used by our staff, to electric. We will support this by reviewing our current car allowances and incentivisation to encourage the shift to electric vehicles for our team.

As this is our first report, we are not yet able to report savings.

In the future we hope to implement further measures such as:

- Introduction of incentives and schemes to encourage our team to move to electric vehicles
- Reviewing policies on when flights are appropriate for our work
- Reviewing policies on when it's appropriate to travel by car, and encouraging greater use of public transport options where these exist.
- Increasing take up of our cycle to work scheme
- Recruiting nationally to reduce travel for geographically spread client base.
- Increase use of teams and virtual meetings wherever possible.
